
QUOTATION CALL NOTICE FOR JALACHHATRA/ WATER KIOSK SERVICE-2022



TERM & CONDITION

1. The intending bidders shall have to furnish EMD of Rs. 15,000/- (Rupees fifteen thousand only) in shape of bank draft in favour of Municipal Commissioner, SMC payable at Sambalpur along with the quotation in the prescribed form vide Annexure-2. EMD of successful bidder will be release after audit.
2. The intending bidders shall have to submit PAN No & GST Regd. No.
3. Quotation without EMD, PAN No & GST Regd. No. Shall be rejected.
4. The successful bidder shall have to install temporary shed/kiosk at each location along with water pot, Mug, Glass and availability of safe drinking water with manpower & fixing of banner from 15th April-2022 to 15th June-2022.
5. The list of 50nos. location within Sambalpur Municipal Corporation area for Jalachhatra shall be provided by this Office. In case any additional locations will be given for water kiosk, then proportionate amount shall be paid in this regard.
6. The Jalachhatra shed/kiosks should be installed at all the designated locations before 14th April, 2021 by the successful bidder after receiving of work order, otherwise necessary proportionate deduction shall be made during the final payment.
7. The payment of bill of Jalachhatra shall be paid to the successful bidder only after satisfactory performance report by the Authorized officer of Sambalpur Municipal Corporation.
8. All the grievances shall be attended by the selected agency with regard to any complaint received regarding functioning of Jalachatra/ water kiosk within 24hours otherwise penalty @ Rs. 500/- (five hundred) per day shall be imposed.
9. The selected bidder shall have to execute an Agreement with the Sambalpur Municipal Corporation in this regard.
