Notice Inviting Tender (NIT)

The Municipal Commissioner, Sambalpur Municipal Corporation invites **percentage bid** in single cover system **through e-Tender** on behalf of Sambalpur Municipal Corporation for the following works from eligible government registered contractors/ Registered NGOs/Registered Firms/Agencies etc. **for providing sanitation services with terms and conditions of the Request For Proposal (RFP) in two bid systems i.e., part-1 (general and Technical bid) and part -2 (Financial bid/Price bid/BOQ).** The proof of registration from the appropriate authority shall be uploaded along with the Bid. Agreement is to be drawn up by SMC with the successful/selected bidder and the prescribed contract form of SMC (Attached to the Bid document)

Department of State Procurement Cell, NIC and designated Bank should not be held responsible or failure of payment by the bidder.

4. **Earnest Money Deposit (EMD):** The EMD amount shall be exempted for all the bidders. The Tender/bid documents of all the bidders must be supported by a **"Bid Security Declaration"** in lieu of Earnest Money Deposit.

5. The Bid documents will be available in the website www.tendersodisha.gov.in **from 07.00 A.M. of dt.14.05.2022 to 10.00 A.M. of dt. 06.06.2022** for online bidding.
6. Bids shall be received only through "online" on or before **10.00 A.M. of dt. 06.06.2022**
7. The signed copy of the bid document along with copy of the supporting documents shall be submitted to below mentioned address through speed post / registry post/ courier only on or before **10.00AM of dt. 09.06.2022.**
8. Bids received online shall be opened at **10.00 A.M.** on dt. **10.06.2022** in the office of the undersigned in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site **through their DSC.** If the Office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
9. The Bidder must possess compatible Digital Signature Certificate (DSC) to participate in e-tender.
10. All original documents along with affidavit of lowest bidder will be verified before issue of work order.
11. Labour Cess @ 1 % (One percentage) will be deducted from the bill of the contractor.
12. **Bidders should read the terms and conditions carefully before bidding.**
13. **The Authority reserves the right to cancel any or all the Bids without assigning any reason thereof.**




