All the bidders are requested to remain present personally during tender opening or send their authorised representative.

Award of contract: -

The SMC will award the contract to the successful bidder whose quotation will be determined to be substantially responsive and who will offer the lowest quotation price.

- a) The successful bidder should make drone and Contour survey of existing water bodies in SMC area for restoration.
- b) The successful bidder should make the survey and submit the details of longitude, attitude, under water level, inlet and outlet etc along with the 3D map of the existing water bodies.
- c) The selected bidder will bear all the cost for both the survey and submission of report along with the 3D map.
- d) The payment will be made to the successful bidder after submission of detail report as per point b & c bill along with the bill as after certification of concerned nodal officer.
- e) In case more than one bidder quoted with same lowest price for same item & then the tender accepting authority will finalize the tender through a transparent lottery system in presence of authorized representatives of the bidder.
- f) The selected bidder will complete the assignment within seven days of issue of work order.
- g) Work order to the successful bidder to be provide by SMC.
