3. Tender Paper Cost of Rs.6000/- (Rupees Six thousand only) in shape of Demand draft from any nationalize bank in favour of the "Commissioner, Sambalpur Municipal Corporation payable at Sambalpur". Which is non-refundable.
4. Refundable EMD of Rs.20,000/- (Rupees Twenty Thousand) only shape of Demand draft from any nationalize bank in favour of the Commissioner, Sambalpur Municipal Corporation payable at Sambalpur. EMD of unsuccessful bidder will be returned immediately after received of written request from the bidders. EMD of successful bidder will be returned after received of performance security.
5. Successful bidder should be submitted a performance security @1% of the contract value in shape of FDR/Bank Guarantee in original for 37 months in favour of the "Commissioner, Sambalpur Municipal Corporation payable at Sambalpur" immediately before issue of Purchase Order.
6. All the prospective bidder who wants to participate in the tender, should have all the necessary certificates from the appropriate authority relating to supply of recovery vehicle to SMC.
7. Undertaking certificate in stamp paper for non-black listed -
8. GST (R/B) filing copy for last six month.
9. Bidder must be submitted positive Net Worth certificate from CA and ITR for last 3 years.
