- 1- The bidder must be a Manufacturer, Authorized Partner, Distributor, Dealer, or Retail Supplier of Decomposing Bio Culture, with proven experience in supplying Decomposing Bio Culture to government entities or sanitation contractors for composting purposes.
- 2- The bidder must furnish documented evidence of relevant experience in supplying Decomposing bio-culture, such as work order from government department.
- 3- The bidder must possess an office within Odisha state and possess a valid Odisha state GST registration certificate. This ensures local compliance and the ability to address project requirements efficiently within the state. Supporting documents must be submitted during bid evaluation.
- 4- The bidder must have prior experience working with Urban Local Bodies (ULBs) in Odisha state. Relevant project completion certificates or work orders must be provided as proof to demonstrate familiarity with local regulations and effective execution of projects.
- 5- The bidder must submit an MSME certificate explicitly stating their capability to supply bio-culture products. This certificate will serve as evidence of their expertise, production capacity, and adherence to quality standards required for bio-culture supply in the project.
- 6- The bidder is required to submit a laboratory test certificate for the Decomposing Bio Culture issued by a Government Accredited Institute, such as those recognized by state or central government authorities.
- 7- The bidder must submit the product brochure.
- 8- The bidder must submit the documents certifying the bidder's legal status / certificate of incorporation / registration of company/ Partnership deed in case of partnership firm.
- 9- The bidder must submit the PAN, GST & MSME Certificate.
- 10- The bidder must submit minimum annual average turnover of Rs. 100 lakhs in last 3 financial years. i.e. FY 2021-22, 2022-23, 2023-24. The bidder must submit audited financial statements i.e. P/L Account and balance duly audited by the CA with valid UDIN Details.

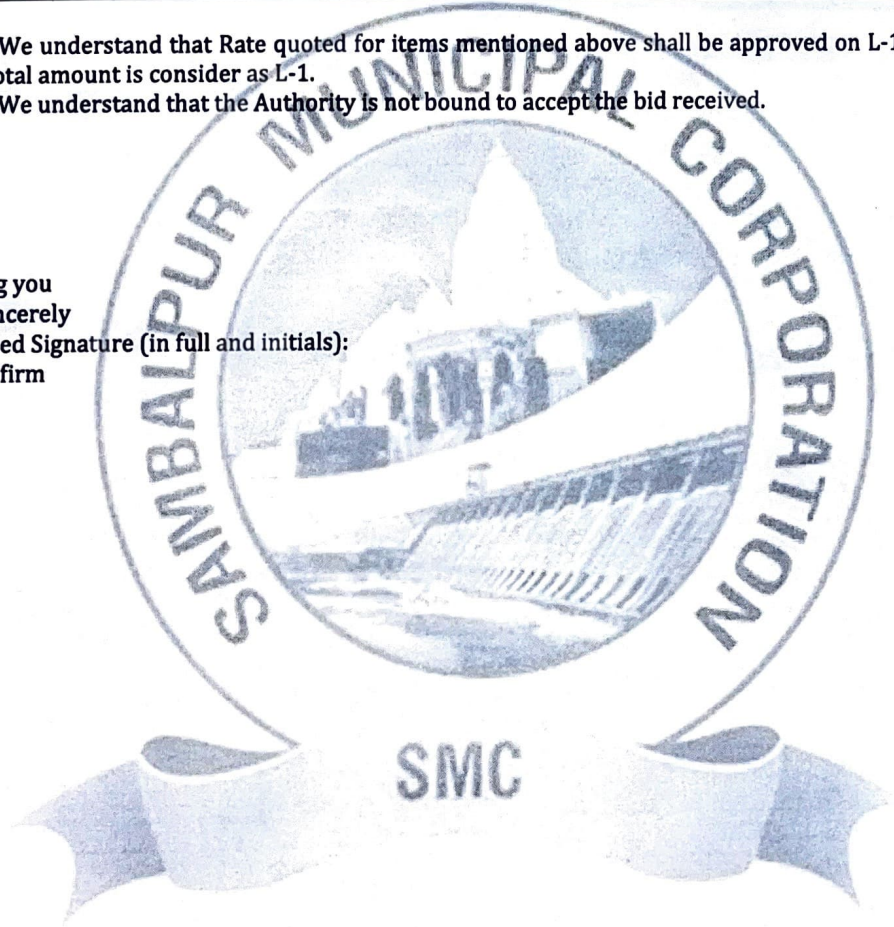
