Fogging Services for Mosquito Control



#### 1. Introduction

Sambalpur Municipal Corporation (SMC) is committed to ensuring a clean, healthy, and safe environment for its citizens. The Corporation seeks to engage a control within the municipal limits of Sambalpur. The purpose of this Request for Proposal (RFP) is to invite bids for the provision of fogging services to control mosquito breeding and transmission of diseases, particularly in high-risk areas.

#### 2. Objective

The objective of this RFP is to identify and select a qualified vendor who can provide effective fogging services aimed at controlling mosquitoes in the designated areas of Sambalpur Municipal Corporation. The selected vendor will be responsible for:

- · Conducting fogging activities on a scheduled basis.
- · Ensuring compliance with all health and safety guidelines.
- · Reporting and monitoring of fogging activities.
- · Providing high-quality mosquito control using appropriate insecticides.

#### 3. Scope of Work

The scope of the mosquito control fogging services includes, but is not limited to, the following:

- Fogging Schedule: Conducting fogging in specified areas of the municipal region based on the approved schedule.
  - o Fogging will be required in residential, commercial, and high-density public areas.
  - o The vendor should plan for night fogging sessions as per the areas of need.
  - o The successful bidder should run the anti-mosquito fogging machine in SMC area at least 25 days in a month and 06hrs per day.
  - o The selected bidder will bear the transportation cost, repair cost and other cost required to run the machine.
  - The selected bidder will bear the cost of any damage to anybody due to accident if occurred during operation of Machine.

### • Types of Areas to be Covered:

- o Residential & commercial areas
- o Streets, roads, and markets
- o Parks, public gardens, and open spaces
- Hospital, school, and other public buildings

#### Equipment and Material:

- The service provider must use fogging machines and insecticides that are safe, effective, and approved by relevant authorities.
- Ensure that all necessary protective gear is worn by the operators.
- Documentation of the chemicals used, including Safety Data Sheets (SDS), for transparency.



## Quality Control and Reporting:

o Provide reports on the fogging activities including the date, location, and

o Provide documentation and feedback to SMC on the effectiveness of the mosquito control program.

Carry out post-fogging evaluations and ensure that there is no negative environmental impact.

## 4. Eligibility Criteria

Interested vendors must meet the following criteria:

1. Compliance: The vendor must comply with Use of approved pesticides and fogging equipment.

2. Technical Expertise: The vendor must have trained personnel to operate fogging equipment and to handle chemicals safely.

3. **Financial Stability**: The vendor must demonstrate financial capability to carry out the work.

#### 5. Submission Requirements

All proposals must include the following:

#### 1. Company Profile:

- o Full name and address of the firm
- o Details of the firm's legal status (partnership, corporation, etc.)

#### 2. Documents:

- Valid GST & PAN.
- o Valid EPF & ESIC registration certificate
- o Proof of financial stability (e.g., bank statement, annual turnover, etc.).

#### 6. Evaluation Criteria

The proposals will be evaluated based on the following criteria

- 1. The work order will be issued to the bidder who has quoted the lowest price (in the financial proposal format Attached at Annexure-I) among the participants.
- 2. In case more than one bidder quoted with same lowest price for same item & then the tender accepting authority will finalize the tender through a transparent lottery system in presence of authorized representatives of the bidder.

- A. Contract Duration: The contract will be for one year with a provision for renewal based on performance.
- B. Payment Terms: Payments will be made as per agreed milestones or on a monthly basis after the successful completion of fogging operations. Bill shall be submitted along with the logbook as well as after certification of concerned nodal officer.
- C. Performance Monitoring: The performance of the service provider will be regularly monitored by the SMC, and the contract may be terminated for unsatisfactory performance.
- D. Confidentiality: The vendor shall maintain confidentiality regarding the operations and processes of SMC.
- E. Force Majeure: Neither party shall be liable for any delay or failure to perform due to unforeseen events outside of their control.
- F. The undersigned reserves the right to accept or reject any or all the tenders without assigning any reason thereof.
