DECISION

Case is taken up today for hearing. This is four years old matter.

2. The appellant Sri Binayak Rath is present. Sri Laxminarayan Patel, Advocate, on behalf of the PIO & FAA, O/o. the Sambalpur Municipal Corporation, Sambalpur is present.
2. A written submission from the First Appellate Authority vide letter No. 7677 dated 15.07.2025 has been received. The complainant had requested for publication of the information U/s. 4 of the RTI Act, 2005 in respect of action taken for imposition of penalty as per Section 118 of Odisha Municipal Corporation, Act, 2003 in the website Sambalpur Municipal Corporation.

He has requested for publication of copies orders of Government of Odisha sanctioning post for Sambalpur, Municipality on permanent basis, copies of Government orders sanctioning posts temporarily. 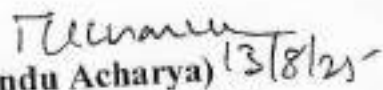

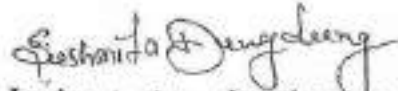
