The Tenders shall be opened in the Conference Hall of Sambalpur Municipal Corporation on 23.12.2025 at 4:30 PM. All bidders are requested to remain present at the time of opening of the Tender.

Selection shall be made on the basis of the **lowest cost Tender** fulfilling the eligibility criteria.
